

# Place des Arts 50/50 Raffle

---

## Rules of Play for 50/50 Electronic Raffle:

1. The 50/50 draw will take place as follows:

Ticket sales start April 1, 2023, at 9:00 AM and will end June 4, 2023, at 9:00 PM. Draw to take place June 5 at 1:00 PM PST.

2. Must be 19 years or older to purchase a 50/50 ticket.

3. Must be in British Columbia (BC) at the time of purchase.

4. After purchasing the ticket, patrons will receive a confirmation e-mail with their 50/50 registered numbers from a Random Selection System. No specific numbers can be given as numbers are generated randomly.

5. Tickets are available online at [trellis.org/placedesarts5050](https://trellis.org/placedesarts5050).

6. Tickets are 5 for \$10, 25 for \$20 and 100 for \$50. Tickets are for the current raffle only and may not be used for future raffles/lotteries.

7. The total tickets for sale are 100 tickets, 5 for \$10; 5,000 tickets, 25 for \$20; 10,000 tickets, 100 for \$50.

8. Tickets will be sold using computer software that utilizes an Electronic Raffle System (ERS) GPED certified software random number generator (RNG), supplied by Trellis.

9. The winning number will be announced online at [trellis.org/placedesarts5050](https://trellis.org/placedesarts5050) and the winner will be contacted through phone and email.

10. The winner may claim their prize by contacting Coquitlam Place des Arts (PdA) by email at [development@placedesarts.ca](mailto:development@placedesarts.ca). The winning Raffle Ticket may then be brought to 1120 Brunette Avenue Coquitlam, BC V3K 1G2 at an agreed upon time for ticket verification. The winner will then be paid by cheque for the amount posted at the 50/50 raffle event for which they bought their ticket. Winners must have the original winning ticket and no copies. The prize claimant will be required to sign a Declaration and Release to receive the cheque. **All payments will be made by cheque.** In the event that a claimant: (a) does not notify PdA within one year of the drawing; (b) is ruled ineligible for any reason; (c) refuses the prize; or (d) does not return an executed Release, the prize will be forfeited and will be retained by PdA for charitable use.

11. Selection of Winner: Upon the conclusion of the Purchase Period, PdA will use the System to randomly generate one winning ticket number from among the numbers associated with purchased tickets. The Raffle will be conducted by a PdA staff member and supervised by a member of the Board of Directors of PdA, and the decisions of that person shall be final and binding.

12. If a situation causes a delay or prevents a draw from occurring, PdA will send out a notice of the substitution date via email notification to all ticket buyers and the details posted on the website.

13. All ticket sales are final. Once a ticket has been purchased, refunds will not be granted. The only exception would be in the unlikely event the raffle is cancelled. At that point BC Gaming Policy and Enforcement rules and guidelines will be followed for proper reimbursement to all ticket buyers. The liability of the licensee of this raffle shall be limited to the purchase price of the ticket(s).

14. The following individuals are not eligible to participate in the 50/50 raffle or to win any Prize: Any employees and board members of Coquitlam Place des Arts involved in the conduct and execution of the raffle.
